Membership can never be more than 1% of the total lawyer population of any state or province. Membership is limited to only those trial lawyers who are unquestionably and eminently qualified, in addition to being regarded as the best in their state/province. Qualifications must include high ethical and moral standards, as well as excellent character.

In 2010, Andrea was inducted as a Fellow in the Litigation Council of America. The Litigation Counsel of America is an invitation-only trial lawyer honorary society. Membership is limited to 3,500 Fellows, representing less than one half of one percent of American lawyers. Fellows are selected and invited into Fellowship after being evaluated for effectiveness and accomplishment in litigation and trial work, along with ethical reputation.

Andrea is also consistently recommended in Best Lawyer and Lexpert in the areas of health care law, administrative & public law, and medical negligence. From 2018 to 2020 she was recognized by Best Lawyer as Lawyer of the Year in Health Care Law for London/Windsor. Andrea has been recognized by Benchmark Canada as a Litigation Star since 2016. She is also ranked in the 2021 edition of Chambers Canada in the area of Healthcare - Contentious.
