### Bankruptcy & Insolvency

- ◆ [Fisgard Capital II Corp. v. Montgomery](#), 2022 ONSC 978 – confirmed that where there are uncontested facts, mortgage enforcement can proceed via application as opposed to an action

### Commercial & Professional Regulation

- ◆ [Matthew R. Harris Professional Corporation v. Carey](#), 2020 ONSC 7808, confirmed that a solicitor cannot proceed with a claim for unpaid fees while a fee assessment that was commenced by the previous before the claim is ongoing.
- ◆ [Fehr v. Gribilas](#), 2023 ONCA 791 – Affirmed previous decision (Fehr v. Gribilas, 2022 ONSC 275) that a claim against client accountant was barred due to the operation of a no-claims over clause

- ♦ [OZ Optics Ltd. v. Evans](#), 2023 ONCA 677 – affirmed previous decision (OZ Optics Ltd. v. Evans, 2022 ONSC 5890) granting summary judgment dismissed the plaintiffs claim against the defendant lawyer for having no tangible cause of action
- ♦ [Zenish Polyfilm LLP v. Alpha Marathon Film Extrusion Technologies Inc.](#), 2023 ONSC 1936 – successful summary judgment motion granting judgment to client for breach of contract related to non-delivery of machinery
