NOTEWORTHY CASES

- ◆ *Cardy v. Trapp* [2008] O.J. No. 4547 (S.C.J.). This was a medical malpractice case involving allegations of a delayed diagnosis of cancer. The defendants were found to have met the standard of care.
- ◆ *Giecwicz v. Hastings*, [2007] O.J. No. 4969 (CA). This case involved an appeal from the CCB regarding treatment incapacity and incapacity to manage property.
- ◆ *Prentice (Litigation Guardian of) v. Coovadia*, [2006] O.J. No. 2799. This was a medical malpractice case in which the defendant psychiatrist was found to have met the standard of care in assessing the suicidality of a voluntary patient in the mental health unit who committed suicide several days following admission.
- ◆ *Meuwissen v. Perkin et al.*, [2006] O.J. No. 5082 (CA). This case involved the propriety of pre-pleading production requests in a putative medical malpractice action.
